## For your information

BT provides radio tower and site supervision for its site sharing customers in accordance with the BT's Code of Practice for Safe Climbing and BT Masts and Towers.

BT Rigging supervision will be required whenever any customer wishes to access a BT tower compound or climb a BT tower or mast.

Supervision and Access are charged based on Weekdays, with the earliest start time of 8am and the latest finish time of 5pm, subject to BT riggers assessment of acceptable daylight and/or weather conditions. Overtime rates are as per the table above.

By exception, BT will consider requests for Supervision at Weekends or on Bank Holidays (Excluding Christmas Day, Boxing Day and New Year's Day) and we will charge a 25% premium.

Requests for Service Tier D01 ('Within 4 hours') can only be considered if a fully completed application form is received before 10am Monday to Friday.

Some remote/hard to access sites may be exempt from D01 'Within 4 hours'. Please contact ht.noc@cellnextelecom.co.uk for more information.

# Full fees will be charged for supervision booked but cancelled with less than two working days' notice.

Once supervision has been confirmed by BT, any amendment to the Supervised Access request or Permit to Climb will incur a  $\pm 250$  fee. A change of date may also result in a further additional charge.

\*\*Note - It is important to acknowledge that the customer may be required to pay for more than one supervisor, contingent upon H&S considerations, the scope of work, and the areas of operation. BT will advise you upon review of the request if this will be required.

#### Explanation of additional charges:

#### Travel charges

All exceptional (flights, ferry, helicopter and all-terrain vehicle hire etc) travel costs will be charged by BT at cost plus 15 per cent.

\*\*Note – If the ATV is supplied by the customer then the appropriate insurance documents must be provided. The acceptance of the ATV will be dependent on the outcome of a risk assessment performed on the day by the BT supervisor.

# If the risk assessment fails then the customer is liable for any abortive costs.

BT cannot guarantee to provide Access or Supervision on demand regardless of requested Service Tier.
